THIS Government Notice updates and changes, where necessary, the provisions of Government Notice No. 389 published in the Government Gazette of 13th April, 2020, in order to reflect the latest changes to the Covid-19 Wage Supplement Scheme as announced by Government.

**1. Tifsir****1. Interpretation**

Għall-ewwel li bdiet tiġi implimentata l-Iskema, id-data dwar l-effetti tal-pandemija fuq in-negozji kienet limitata u l-għajjnuna giet determinata abbażi ta' dak li kien meqjus bħala apporzzjonament ġust tas-supplimenti mensili ta' €800 skont l-attività prinċipali

The Covid-19 Wage Supplement ensures a minimum income to employees and supports the sustainability of business affected by the Covid-19 pandemic. In the initial implementation period, the data available on the effects of the pandemic on businesses was limited and the aid was determined on the basis of what was considered as a fair apportionment of a maximum monthly wage supplement of
