Sanctions Monitoring Board Declaration

NGHARRFU illi li skont l-artikolu 7(5)(b) tal-Att dwar Poteri li jsiru Regolamenti fl-Interess Nazzjonali, Kapitolu 365 tal-Liġijiet ta' Malta, il-Bord ta' Sorveljanza fuq Sanzjonijiet jiddikjara li l-bastimenti msemmija f'din id-dikjarazzjoni għandhom jitqiesu bhala ffrizati:

IT is notified that in terms of article 7(5)(b) of the National Interest (Enabling Powers) Act, Chapter 365 of the Laws of Malta, the Sanctions Monitoring Board declares the following vessels are to be deemed as frozen:

MSC Valencia (Numru IMO 9301471)
MSC Bilbao (Numru IMO 9301495)

MSC Bilbao (IMO Number 9301495)

Il-bastimenti qed jiġu ddikjarati bhala ffrizati peress li huma meqjusa li jappartjenu, direttament jew indirettament, għal entità elenkata taħt ir-Regolament tal-Kunsill 269/2014 tas-17 ta' Marzu, 2014 dwar mizuri restrittivi fir-rigward ta' azzjonijiet li jimminaw jew jheddu l-integrità territorjali, is-sovranià u indipendenza tal-Ukrajna.

The vessels are being declared as frozen since they have been deemed to belong, directly or indirectly, to an entity listed under Council Regulation 269/2014 of 17 March, 2014 concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine.

Il-Bord ta' Sorveljanza fuq Sanzjonijiet b'dan jiddikjara li l-bastimenti jistgħu jinbiegħu permezz ta' bejgħ ġudizzjarju b'irkant jew bejgħ privat approvat mill-Qorti debitament awtorizzat mill-Qrati Maltin, f'liema każ, il-bastimenti għandhom jiġu trasferiti hielsa u bla tfixkil lix-xerrejja rebbieha. Fir-rigward tad-dħul mill-bejgħ iddepożitat fil-Qorti, apparti l-ammont dovut lill-kredituri tal-bastimenti bi pretensjonijiet kontra l-bastimenti qabel il-bejgħ ġudizzjarju (inklużi l-ispejjeż relattivi kollha tal-qorti), dan għandu jitqies bhala ffrizat.

The Sanctions Monitoring Board hereby declares that the vessels may be sold by means of a judicial sale by auction or a court approved private sale duly authorised by the Maltese Courts, in which case, the vessels shall be transferred free and unencumbered to the successful purchasers, whilst with respect to the proceeds of the sale deposited in court, save for the amount due to the vessels' creditors with claims against the vessels prior to the judicial sales (including all relative court expenses), such proceeds shall be deemed as frozen.
