## 1. Terms and Conditions

1.1 The subject of this Call for Quotes is for the Hiring of Emergency Lights for Polling Booths during election period.

1.2 The aim of this call is to hire 800 emergency lights for a three (3) week period during election time. The delivery of the emergency lights is to be made by 22<sup>nd</sup> May 2026.

## 2. Specifications

2.1 The Emergency Lights are to include the following:

- 60 LED;
- Battery operated;
- Rechargeable battery with red indicator charging light;
- Ready with full charge on delivery;
- With two (2) different brightness settings

## 3. Instructions to Bidders

3.1 Please note that quotations should be in **Euro currency**. Prices quoted are to be quoted Duty Delivery Paid and VAT component quoted separately. Where a payment transaction does not include a currency conversion, the payee shall pay the charges levied by his payment service provider, and the payer shall pay the charges levied by his payment service provider.

3.2 Quotations are to be deposited by hand in the Tender Box at the Electoral Office, Counting Hall Complex, Ex. Trade Fair Grounds, Naxxar. Only quotations delivered by hand will be considered.

3.3 Quotations must be valid for a minimum of 90 days.

3.4 Delivery costs must be included in all received quotes.

- 3.5 The price submitted in the Financial Bid should be the Unit Price (excluding VAT). Bidders are also requested to indicate the Unit Cost for any missing and/or damaged emergency lights.
- 3.6 The wattage of emergency lights being offered should be included in the Financial Bid Form.
- 3.7 The emergency lights are to be delivered to the Electoral Commission **fully charged and ready for use**.
- 3.8 The Electoral Commission reserves the right to impose Penalties amounting to €20.00 per calendar day (beyond the agreed delivery period) if items are not delivered within the time stipulated in the quote submitted by the awarded bidder. (ex. Bidder who deliver items after 5 calendar days after the agreed delivery period will be fined a total of € 100.00).
- 3.9 Clarifications can be sought up to THREE (3) WORKING DAYS before the closing date. Any queries and requests for clarifications are to be sought only via email on [procurement.electoral@gov.mt](mailto:procurement.electoral@gov.mt). All clarifications will be posted by the Electoral Commission within a reasonable time on the notice board at the Counting Hall Complex, Ex.Trade Fair Grounds, Naxxar, Malta.
- 3.10 All quotations must include the Manufacturer's Details. The Department reserves the right to disqualify any quotations which do not include such details.
- 3.11 Bidders must quote all components of the price **inclusive** of taxes, customs and import duties and any discounts. Bidders not registered with the VAT authority in Malta, must **still** include in their financial offer any VAT that the Electoral Commission may have to pay either in Malta or the country where the applicant is registered irrespective of the reverse charge mechanism. The financial offer will be considered as the total financial cost to the Electoral Commission including any VAT that may

have to be paid not through the winning applicant. Except as may otherwise be provided for in the contract, no payment will be made for items which have not been costed.

- 3.12 If the bidder offers a discount, the discount must be absorbed in the rates of the Financial Bid. The prices for the contract must include all of the supplies/works to be provided. The prices quoted are fixed and not subject to revision or escalation in costs.

#### **4. Performance Guarantee**

- 4.1 In case that the contract value exceeds €10,000 including VAT, the awarded bidder will be required to furnish within 7 days of receipt of the notification of award of contract, a performance guarantee equivalent to 10% of the contract value (including VAT). This is to be provided in the format as shown in Form 1 *Specimen of Performance Guarantee* (further down).
- 4.2 In case the contract value does not exceed €10,000 including VAT, no performance guarantee is required.

#### **5. Literature**

- 5.1 Relevant **Literature** about the product being offered is to be submitted with the quotation.
- 5.2 In case of chemicals, chemical compounds, chemical mixtures and/or other hazardous material (including detergents, soaps, cleaning products, lubricants, etc.), a valid **Material Data Safety sheet** is to be submitted with the quotation. Should this document not be supplied when such material is offered, the offer will be automatically disqualified.

## 6. CE Marking

The clauses in italics are applicable only for Products which must carry the CE Mark as per Maltese and European Legislation.

- *Applicants must conform with CE standards and any applicable local legislations and thus, shall be bound to submit the Declaration of Conformity upon request. (where applicable)*
- *Quoted Item is to include CE mark wording, basic compliance requirements and certifications on specifications. The CE mark is to be present on the outer pack, instructions leaflet, and where possible, on the product itself. The CE-mark must be in a specific format as shown in Figure 1. No other marks will be considered acceptable. (where applicable)*

- *Quoted Item is to display relevant information and warnings as specified in Annex 1 Section 13 of Directive 93/42/EEC. (where applicable)*
- *Given information, specifications and manuals must be in English or Maltese. Applicants submitting information, specifications and manuals in other languages only will be automatically disqualified. (where applicable)*
- *The outer pack and leaflet of the Quoted item is to bear the FULL name and address of the manufacturer. The product itself, where possible, must also bear the FULL name and address of the manufacturer. If the manufacturer is based outside the EU, the full name and full address of his officially appointed EU authorised representative must also be present. Thus, products manufactured outside the EU are to bear TWO addresses. (where applicable)*

- *Sterile devices, measuring devices medium-to-high risk devices, must bear the Notified Body 4-digit number. (where applicable)*
7. Services offered that do not conform to specifications will not be considered.
  8. Call will be awarded to the cheapest offer which is fully compliant with the Administrative, Technical and Financial Requirements.
  9. Please note that it is entirely the Applicant's responsibility to ascertain that the quote is submitted BEFORE the deadline for submission of quotations.
