

The following land at Ħ'Attard:

1. Biċċa art tal-kejl ta' madwar 11-il metru kwadru, li tmis mit-Tramuntana u mill-Punent ma' proprjetà tal-Gvern u mil-Lvant ma' proprjetà ta' sidien mhux magħrufa jew irjieħ verjuri.

1. A plot of land measuring about 11 square metres, bounded on the North and on the West by Government property and on the East by property of unknown owners or more precise boundaries.
