WE, the undersigned, being the Electoral Commissioners commissioned by His Excellency the President of Malta by a writ dated 28th March, 2011, for the conduct of a referendum on the 28th day of May, 2011, in terms of subarticle (1) (a) of article 3 of the Referenda Act (Cap.237), hereby declare that the result of the vote to the question "Do you agree with the introduction of the option of divorce in the case of a married couple who has been separated or has been living apart for at least four (4) years, and where there is no reasonable hope for reconciliation between the spouses, whilst adequate maintenance is guaranteed and the children are protected?" is shown hereunder.
